1. To provide the proper insurance coverage when hauling and using equipment
2. To perform an inspection of the equipment for damage prior to taking it into my possession and to report any damage to the District office immediately.
3. To immediately contact the District when I pick up and return the equipment.
4. To report to the District the actual number of acres used upon return.
5. To assume responsibility for any repairs due to my negligence or use, excluding ordinary wear and tear while the equipment is in my possession.
6. To be responsible for the transport of the equipment to and from the District parking lot.
7. **To provide payment to the District within 30 days of returning equipment with the understanding that balances over 30 days will be subject to a 1 1/2% interest. Further rentals will be denied until the balance is paid in full. Delayed payments will be subject to the requirement of a cash prepayment on future rentals.**
8. If I fail to return the equipment to the district within a reasonable amount of time, baring weather conditions and/or equipment malfunctions I agree to pay a fine of \$100.00 to the District.
9. I will bring the equipment back to the District clean, with no seed in the boxes or covered with mud.
